

FIRST AMENDMENT TO AGREEMENT

THIS FIRST AMENDMENT TO AGREEMENT is made and entered into on the date of the City's signature page by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado ("City"), and **CENTURYLINK COMMUNICATIONS, LLC, d/b/a LUMEN TECHNOLOGIES GROUP** a Delaware Limited Liability Company, authorized to do business in the State of Colorado ("Contractor") (collectively, the "Parties").

WITNESSETH:

WHEREAS, the Parties entered into a Master Services Agreement (Contract No. 201525744) at Denver International Airport ("DEN") dated May 29, 2018, (the "Existing Agreement") to provide telecommunications services and professional services on an as-needed basis for high-speed internet, Synchronized Optical Network (SONET) managed network services, Distributed Denial-of Service (DDoS), 1FB and PRI, web hosting services, and other related telecommunication services at DEN;

WHEREAS, the City is using a new contract management software system, and as a result, the contract number for this Agreement is being changed from 201525744-01 to 202157945-01;

WHEREAS, the parties desire to amend the Existing Agreement in order to extend the Term and increase the Maximum Contract Amount;

NOW, THEREFORE, for and in consideration of the premises and other good and valuable consideration, the sufficiency of which is acknowledged, the parties hereto agree as follows:

1. Paragraph 3 titled "Term" is hereby amended and restated to read as follows:

"3. Term: The Term of this Agreement shall commence on the Effective Date and shall terminate five (5) years thereafter on May 28, 2023, unless sooner terminated under the provisions of this Agreement. The Order Term or Service Term for a particular Service is defined in the applicable exhibit. CenturyLink will not accept new orders after the expiration or termination of the Agreement, but the Agreement will continue to apply to any unexpired orders or SOWs properly placed during the Term."

2. Paragraph 4.D.(i) titled "Maximum Contract Liability; Allocation of Maximum Contract Liability Among Service Exhibits", is hereby amended and restated to read as follows:

"D. Maximum Contract Liability; Allocation of Maximum Contract Liability Among Service Exhibits:

(i) Any other provision of this Agreement notwithstanding, in no event shall City be liable to pay for services rendered and expenses incurred by Contractor under the terms of this Agreement for any amount in excess of Six Million Two Hundred Sixty-Nine Thousand Three Hundred Eight Dollars and Eighty-Four Cents (\$6,269,308.84) ("Maximum Contract Liability"). Funding under the provisions of this paragraph 4.D.(i) is

payable from the City and County of Denver Airport System Fund. The Contractor acknowledges that the City is not obligated to execute an order, agreement or an amendment to this Agreement for any services and that any services performed by Contractor beyond that specifically described herein are performed at Contractor's risk and without authorization under this Agreement."

3. Except as otherwise provided herein, all of the terms, provisions, and conditions of the Existing Agreement shall remain in full force and effect as though set out in full here, and are hereby ratified and reaffirmed.

4. This First Amendment to Agreement shall not become effective or binding on the City until it is approved by the City Council if so required by the City's Charter, and it is fully executed by all signatories of the City and County of Denver.
