This amendment of an agreement between the Urban Drainage and Flood Control District (UDFCD) adds additional funds for the design and construction of drainage and flood control structures on Cherry Creek between Monaco Parkway and Iliff Boulevard. This amendment adds \$250,000 of Wastewater enterprise funds and \$250,000 of UDFCD capital funds to \$700,000 already agreed to by CCD and UDFCD for a total of \$1,200,000. These funds are held by the UDFCD and the UDFCD will manage the design and construction.
