A BILL

for an ordinance amending Chapter 18 of the Revised Municipal Code to establish the 2016 and 2017 salary and fringe benefits of the Sheriff, Deputy Sheriff Division Chiefs and Deputy Sheriff Majors.

BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. That effective January 1, 2016, Chapter 18, Article IV, Section 18-101 of the Revised Municipal Code is hereby amended to read as follows:

Sec. 18-101. Deputy sheriff major, deputy sheriff division chief, and sheriff pay plans.

- (a) Effective January 1, 2016, The annual salary range for deputy sheriff majors, deputy sheriff division chiefs and the sheriff shall be as follows:

Deputy sheriff major: ~~\$96,772 – \$128,705~~ \$132,888

Deputy sheriff division chief promoted or appointed before January 31, 2016: ~~\$109,986 – \$149,860~~ \$154,730

Deputy sheriff division chief appointed on or after February 1, 2016: \$164,783

Sheriff: ~~\$128,201 – \$171,539~~ \$177,114

- (b) Effective January 1, 2017, the annual salary for deputy sheriff majors, deputy sheriff division chiefs and the sheriff shall be as follows:

Deputy sheriff major: \$136,875

Deputy sheriff division chief promoted or appointed before January 31, 2016 _____:
\$159,373

Deputy sheriff division chief appointed on or after February 1, 2016: \$169,726

Sheriff: \$182,427

Section 2. That effective January 1, 2016, Chapter 18, Article IV, Section 18-114 of the Revised Municipal Code is hereby amended to read as follows:

Sec. 18-114. Acting pay.

Effective January 1, ~~2015~~ 2016, a deputy sheriff division chief who, for a period of eight (8) consecutive work hours or more, is temporarily assigned to act as the sheriff shall be compensated at the rate of pay of the sheriff, in lieu of the salary of deputy sheriff division chief,

1 for such time assigned to act as the sheriff; and, a deputy sheriff major who, for a period of eight
2 (8) consecutive work hours or more, is temporarily assigned to act as a deputy sheriff division
3 chief shall be compensated at the pay rate of deputy sheriff division chief, in lieu of the salary of
4 deputy sheriff major, for such time assigned to act as a deputy sheriff division chief. ~~In either such~~
5 ~~case, the applicable pay rate (1) a nine and one-half percent (9.5%) increase above the~~
6 ~~individual's existing pay rate as a deputy sheriff division chief or deputy sheriff major, or (2) the~~
7 ~~salary range minimum for the higher rank, whichever is greater.~~
