CCD agrees to pay two-thirds (2/3) of the twenty percent (20%) Local Match requirement from the USDOT Grant, totaling \$1,329,833.00 as costs are incurred. The proposed reconstruction improvements are occurring along three and one-half (3 ½) blocks along the 16th Street Mall between Broadway and Court, and between Lawrence and Market. Proposed improvements include: paver rehabilitation; sub-base reconstruction; intersection bulb-outs; wet and dry utility upgrades; urban design improvements; and mall livability elements.
