**A BILL**

**For an ordinance establishing a new fund in the Safety Special Revenue Fund Series for the “Denver District Attorney State Grants” program.**

**WHEREAS**, the Denver District Attorney has been awarded a grant from the State of Colorado and currently lacks a fund to administer the award;


**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new fund is hereby established in the Safety Special Revenue Fund Series, Accounting No. 12000, a “Denver District Attorney State Grants” Fund, Accounting No. 12307, for the purpose of accounting for the receipt and expenditure of state grants awarded to the Denver District Attorney’s Office.

**Section 2.** Monies received from state awards supporting a community safety purpose, including, but not limited to, programs related to family and domestic violence, diversion, and human trafficking shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** Expenditures are hereby authorized for the “Denver District Attorney State Grants” Fund, Accounting No. 12307, in the amount not to exceed the amounts awarded as described in Section 2 of this Ordinance, to be expended by the Denver District Attorney or his or her designate or other authorized officials. This Fund is sponsor-funded and non-lapsing.

**Section 4.** The Chief Financial Officer of the City and County of Denver is hereby authorized and directed to make such book and record entries and to do such other things as may be necessary to accomplish the purposes of this Ordinance.
