5 **A BILL**

6 **For an ordinance approving the issuance of a series of Sewer Use and Drainage**
7 **Permits by the City and County of Denver for property located at 7210 East**
8 **Colorado Avenue, Arapahoe County, to provide sanitary sewer and/or wastewater**
9 **services to property located outside City limits.**

11 **WHEREAS**, the proposed Sewer Use and Drainage Permits by the City and County of Denver
12 for property located at 7210 East Colorado Avenue, cannot be issued by the proper officials of the City
13 and County of Denver until after approval action or inaction by the Council of the City in accordance
14 with Subsection 56-97(a)(4) of the Revised Municipal Code of the City, because the Sewer Use and
15 Drainage Permits provide for the carriage of wastewater of a person or entity outside the geographical
16 limits of the City; and

17 **WHEREAS**, the City has duly reviewed the proposed Sewer Use and Drainage Permits;

19 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**
20 **DENVER:**

21 **Section 1.** The proposed Sewer Use and Drainage Permits with respect to property located
22 at 7210 East Colorado Avenue, in the words and figures contained and set forth in the form of Sewer
23 Use and Drainage Permits filed in the office of the Clerk and Recorder, Ex-Officio Clerk of the City and
24 County of Denver, under City Clerk's Filing No. 20200091 are hereby approved.
