Bollinger Dr. "Amache Prowers Memorial Park". 7 8 9 **WHEREAS**, the City and County of Denver entered into an agreement with Denver Connection West Metropolitan District ("District") to share in the cost of the construction and 10 11 development of the unnamed park at approximately Kittredge St. and E. Bolling Dr., Denver, 12 Colorado 80239; and 13 WHEREAS, recognizing that the District had no prior obligation to make any contribution to 14 the construction and development of the park, the Department of Parks and Recreation has 15 accepted the District's generous contribution as a gift of the park to the City; and WHEREAS, in accordance with the procedure established by the Department of Parks and 16 17 Recreation's Naming Policy, the Executive Director of the Department of Parks and Recreation 18 submitted a proposal to the Parks and Recreation Advisory Board to name the park "Amache 19 Prowers Memorial Park"; and WHEREAS, the purpose of the naming is to honor the indigenous activist and advocate 20 21 Amache Prowers; and to honor her work as a mediator between Colorado territorial settlers, Mexicans and Native Americans in the mid to late 19th century. This park would be a tribute to her 22 23 dedication to the cultural understanding, community leadership and role in shaping Colorado; and 24 **WHEREAS**, the Executive Director of the Department of Parks and Recreation supports the proposed naming of this park; and 25 26 **WHEREAS**, the Department of Parks and Recreation further supports the District's request to name the park "Amache Prowers Memorial Park" in recognition of the District's gift; and 27 28 WHEREAS, the Denver Parks and Recreation Advisory Board voted at its meeting on September 10, 2025, to recommend the naming of the unnamed park as "Amache Prowers 29 30 Memorial Park". BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER: 31 32 Section 1. That the park, the same is hereby named, and shall be known as, AMACHE PROWERS MEMORIAL PARK. 33 34 Section 2. That this action shall be effective upon the final adoption of the ordinance.
