A BILL

For an ordinance authorizing expenditures in the Economic Opportunity Special Revenue Fund for the "Temporary Assistance for Needy Families (TANF) Case Management, Employment, and Training FY15-16" program.

WHEREAS, the Office of Economic Development, Division of Workforce Development, provides case management services through the Employment and Training program for TANF participants; and

WHEREAS, the grantor is the U.S. Department of Human Services; the funds are provided to Denver's Department of Human Services (DHS) through the Colorado Department of Human Services. Through an MOU, DHS provides these funds to the Division of Workforce Development. This appropriation represents a partial funding of PY15/16 grant award; and

WHEREAS, the Denver Department of Human Services reimburses the Office of Economic Development for said services;

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. Expenditures are hereby authorized from the Economic Opportunity Special Revenue Fund, Accounting No. 17000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:

1 The foregoing authorization will provide employment and training services to TANF participants
2 and to TANF-eligible individuals for the purpose of increasing work participation and improving the
3 chances for self-sufficiency, thereby reducing the number of Denver families in poverty.
4 Authorization for expenditure of said funds following execution of said grant represents partial
5 funding of the entire grant award and will cover the period from July 1, 2015 through June 30,
6 2016.

7 **Section 2.** The Manager of Finance of the City and County of Denver is hereby authorized
8 and directed to make such book and record entries and to do such other things as may be
9 necessary to accomplish the purposes of this Ordinance.
