9 For an ordinance approving and providing for the execution of a proposed grant
10 agreement between the City and County of Denver and Kaiser Permanente
11 concerning the "Free Recreation Centers for Youth FY10" program and the funding
12 therefor.

14 WHEREAS, the City and County of Denver has given due consideration to said proposed
15 Grant Agreement;

16 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY
17 OF DENVER:

18 Section 1. The proposed Grant Agreement between Kaiser Permanente and the City and
19 County of Denver, a copy of which is duly filed with the City Clerk, Filing No. 10-482, be and
20 hereby is approved in all respects.

21 Section 2. The Mayor or his lawful successor and other proper officials of the City and
22 County of Denver, in its behalf, are hereby authorized and directed to execute said Grant
23 Agreement and the Clerk and Recorder of the City and County of Denver is hereby authorized
24 and directed to attest and impress the official seal of the City and County of Denver on the Grant
25 Agreement.

26 Section 3. The Mayor, his successor in office, or his duly authorized representatives, and
27 other officials of the City are hereby authorized and directed to do all things required to be done
28 in order to obtain payments under the Grant Agreement, including, but not limited to, filing
29 requests for payments, contracting with persons and organizations in order to carry out the
30 provisions of the Grant Agreement, filing reports and keeping records relating to fiscal and
31 evaluation matters, and forwarding other materials to Kaiser Permanente.

32 Section 4. The payments made by Kaiser Permanente to the City pursuant to and under
33 the Grant Agreement shall be deposited into the Treasury of the City and credited to Special
34 Fund No. 15000, which is set forth and described in Section 20-18 of the Revised Municipal
35 Code of the City and County of Denver.

1 Section 5. That it be and is hereby found and determined that the budget summary of said
2 "Free Recreation Centers for Youth FY10" Program, Accounting Number 15608-7011101-
3 R4011, is as follows, to be expended by the Manager of Parks and Recreation.

4 Kaiser Permanente \$ 150,000

5 Authorization for expenditure of said funds following execution of said grant will cover the
6 period from May 1, 2010 to October 30, 2010.

7 Section 6. The Manager of Finance of the City and County of Denver is hereby authorized
8 and directed to make such book and record entries and to do such other things as may be
9 necessary to accomplish the purposes of this Ordinance.
