**A BILL**

**For an ordinance assessing the annual costs of the continuing care, operation, security, repair, maintenance and replacement of Skyline Park Local Maintenance District upon the real property, exclusive of improvements thereon, benefited.**

**BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Upon consideration of the recommendation of the Executive Director of the Department of Transportation and Infrastructure that an ordinance be enacted for the purpose of assessing the annual costs of the continuing care, operation, security, repair, maintenance and replacement of Skyline Park Local Maintenance District (“Skyline Park LMD”), for the upcoming year, upon the real property, exclusive of improvements thereon, benefited the Council finds, as follows:

(a) A local maintenance district providing for the continuing care, operation, security, repair, maintenance and replacement of Skyline Park LMD, was created by Ordinance No. 1321, Series of 2018, as amended and restated by Ordinance No. 921, Series of 2021;

(b) The annual cost of the continuing care, operation, security, repair, maintenance and replacement of Skyline Park LMD is \$313,450.00, which amount the Executive Director of the Department of Transportation and Infrastructure has the authority to expend for the purposes stated herein;

(c) The Executive Director of the Department of Transportation and Infrastructure has complied with all provisions of law relating to the publishing of notice to the owners of real properties to be assessed and to all persons interested generally, and the Council sitting as a Board of Equalization has heard and determined all written complaints and objections, if any, filed with the Executive Director of the Department of Transportation and Infrastructure;

(d) The real property within Skyline Park LMD will be benefited in an amount equal to or in excess of the amount to be assessed against said property because of the continuing care, operation, security, repair, maintenance and replacement of said Skyline Park LMD.

**Section 2.** The annual cost of the continuing care, operation, security, repair, maintenance and replacement of Skyline Park LMD to be assessed against the real properties, exclusive of improvements thereon, benefited are hereby approved.

1           **Section 3.** As Skyline Park LMD currently has sufficient reserves to pay for the 2023 annual  
2 costs of the continuing care, operation, security, repair, maintenance and replacement of Skyline  
3 Park LMD, no additional amounts shall be assessed against properties in the District.

4           **Section 4.** Any unspent revenue and revenue generated through investment shall be  
5 retained and credited to Skyline Park LMD for future long term or program maintenance of the  
6 District.
