Attach executive summary if more space needed:** The purpose of these on-call contracts is to maintain a pool of available contractors to provide as needed general construction services and related expertise to support the delivery of DEN's capital infrastructure programs and projects. The types of services include, but are not limited to: Construction Management, Subcontractor Management, Quality Control, Surveying, Safety Management, and As-Built Development. These services may be required on projects involving multiples trades, including Structural, Mechanical, Electrical, Plumbing, and Pavements skill sets. Additionally, contractors may be tasked for pre-construction services in order to guide decisions during the design process, develop preliminary cost estimates, and develop preliminary schedules.

The on-call general construction services provided under this contract will support DEN in achieving its Maintaining What We Have and Growing Our Infrastructure Vision 100 elements, ensuring Denver International Airport's continued success and efficiency. Through collaborative efforts and adherence to high standards of construction excellence, the contractors will contribute to DEN's mission of providing a world-class airport experience for passengers and stakeholders.

Scope of work: The scope of work encompasses a wide range of construction projects spread across the airport premises, including the main terminal, concourses, airfield, and surrounding areas. These projects vary significantly in nature and complexity, such as gate expansions, office remodels, concourse renovations, interior finishes, structural repairs, apron concrete repair and paving, and gate relocations. A general contractor is required to coordinate these activities efficiently, liaising with subcontractors and potentially participating in the design phase of projects. DEN favors the design-build delivery method and expects contractors to collaborate closely with design consultants, providing input to guide design decisions and develop preliminary cost and schedule documents.
