7 **For an ordinance authorizing a capital equipment purchase from the Risk**  
8 **Management Fund (SRF 11838) Fund for the Denver Public Library.**

10 **WHEREAS**, the Denver Public Library (DPL) is seeking approval for a capital equipment  
11 purchase of two replacement vehicles to be used for snow and ice control at library locations; and

12 **WHEREAS**, DPL relies on said vehicles to keep library branches safe and accessible and to  
13 open in a timely manner during weather events with snow and ice conditions; and

14 **WHEREAS**, said vehicles are replacement of two city vehicles, one vehicle was totaled in a  
15 hit-and-run and the other vehicle was totaled by arson; and

16 **WHEREAS**, said replacement vehicles are authorized to be purchased from the Department  
17 of Finance (DOF), Risk Management Special Revenue (11838) for an amount up to \$114,550, and  
18 anything above that amount will be paid from the Denver Public Library Fund Special Revenue  
19 Fund (15830); and

20 **WHEREAS**, because this is a capital equipment purchase above the fifty-thousand-dollar  
21 threshold, DPR requires City Council authorization to purchase said vehicle;

23 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**  
24 **OF DENVER:**

26 **Section 1.** From the Risk Management Special Revenue Fund, Accounting No. (11838) and  
27 the Denver Public Library Fund Special Revenue Fund (15830), the Chief Financial Officer, or duly  
28 authorized representatives, is hereby authorized to purchase or acquire the following capital  
29 equipment:

1 The foregoing vehicle purchase is to support the operations of the Denver Public Library.

3 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
4 and directed to make such book and record entries and to do such other things as may be necessary  
5 to accomplish the purposes of this Ordinance.
