11 and County of Denver and State of Colorado Department of Transportation concerning the  
12 “Federal Highway Safety Improvement Program (HSIP) Package 4” and the funding therefor; and

13 **WHEREAS**, this amendment maintains the original funding level and does not change the  
14 previously authorized amount; and

15 **WHEREAS**, this amendment revises the project scope, which triggers the requirement for  
16 City Council approval; and

17 **WHEREAS**, the City and County of Denver has given due consideration to said proposed  
18 Grant Agreement;

26 of which is duly filed with the City Clerk, Filing No. 202472684, be and hereby is approved in all  
27 respects.

29 and directed to make such book and record entries and to do such other things as may be necessary  
30 to accomplish the purposes of this Resolution.
