- 5. Describe the proposed ordinance, including what the proposed ordinance is intended to accomplish, who's involved
 - a. Scope of Work

This amendment will allow the Enterprise Cashiering Solution Program to be implemented to additional City and County of Denver agencies as outlined in the 5 year rollout plan (see executive summary). The program provides secured point of sale and online payments, standardizes receipting and cash handling functions, and supports PCI (Payment Card Industry) compliance.

The Enterprise Cashiering Solution Project began in 2010 and is the ongoing roll out to implement a consistent, state of the art point-of-sale and online payments system in city agencies. It provides standardized, industry standards and best business practices for secured, automated payments, cash receipting and cash handling.

Active Network was the selected through a competitive City Request for Proposals process in 2010. Beginning in 2011, the system was first rolled out to Treasury (on-line payments of property taxes), Wastewater, Community Planning and Development, Public Works-Composting and Parks-Donations. Currently, the system is being implemented in the Animal Shelter, and Environmental Health. This ordinance request will allow the roll out to the Electronic Monitoring, Vehicle Impound, Office of Economic Development, Parking Management, Human Services and the remainder of Manager of

Safety. The amendment will add an additional \$1,472,520 to the contract for a total \$1,900,722. The term is also being extended three additional years to reflect that it will take five years to implement the system City-wide and will provide agencies at least three years of use before considering a replacement solution.

The Enterprise Cashiering Solution provides improved customer experience and convenience through online payments, cross agency payments, and automated updating of customer records. The solution also provides improved and standardized cash handling policies and procedures, automated updating of city financial records, automated and accelerated deposit of city funds for lower processing costs and increased investment income, all with Payment Card Industry Data Security Standards compliant functionality and security.
