 - **Latinx Programs:** Supported the Latinx Program manager in the facilitation and expansion of SEPA (Salud/Health, Educación/Education, Prevención/Prevention, Autocuidado/Self-care) programming, including outreach for HIV/STI/Hep C testing, to five counties in Colorado, reaching over 80 mono- and bi-lingual Hispanic/Latina women within these new service areas. Facilitated new partnerships for Latinx Programs with the University of Colorado School of Nursing, collaborating on developing a Telenovela *Viviendo Positivos*, a self-management intervention for Latinos with HIV.
