TERM EXTENSION OVERVIEW



- DEN has identified a group of concession contracts that were competitively bid, but did not receive the Premium Concession Program award, COVID-19 Extensions, or the new concession contract term limits that were introduced on January 1, 2024
- DEN is in the process of amending these agreements to right size these contracts that were competitively bid to align with the new contract term lengths, based on the increased cost of designing and building a Concession at DEN. This amendment will help the concessionaires amortize their investment due to the rising capital investment costs
- This group of contracts is considered by the Airport as Group 2, “Middle Earth” concessions
 - The first 14 amendments passed Full City Council on September 29 (see last slide)
 - The remaining amendments are either in the Council process now, or will be very soon

- There are three groups of concessionaires that have received different levels of support from the airport and federal funds:
 - Group 1: “Old School”
 - Awarded beginning in 1995
 - Group 2: “Middle Earth”
 - Awarded after 2019 and before Jan 1, 2024
 - Group 3: “Newbies”
 - Longer contract terms effective Jan 1, 2024

GROUP 2: “MIDDLE EARTH”



- The original terms are 7 and 10 years for food and beverage, and 7 years for retail locations
- These concessionaires lack the legacy benefits of Group 1 and the modern agreements from Group 3
- These contracts did not receive Premium Value Concession awards or COVID extensions
- These Group 2 concessions are the contracts DEN is bringing forward for amendment today
