Throughout the term "Pepsi Center" is deleted and replaced with "Ball Arena" Adds language requiring Nuggets LP, Avalanche LC and Kroenke Arena to execute the First Amendment, as well as requiring that the Guarantors execute the First Amendment and provide a restated guaranty. Also requires that Nuggets LP and Avalanche LLC to file amended statements to reflect the new terms in the central records of Colorado, Missouri and Delaware.
