In 2002, the City deeded to the Metropolitan Football Stadium District ("District") parcels known as Stadium Parcels B6, B7 and B8. As part of the 2002 transaction, the deed contained restrictions allowing use and re-entry to the City if the District used the property for purposes other than the agreed upon uses. The Partial Release of Use Restriction and Right of Reentry for CDOT Parcel authorizes the release of the use restriction and right of re-entry for the CDOT parcel and easement area. CDOT intends to construct a new headquarters on the parcels.
