Re: FY24 Adult Diversion and Correctional Treatment Fund Award

Dear District Attorney McCann and Ms. Martin,

I write to you on behalf of the Adult Diversion Funding Committee with good news about overall adult diversion funding and specifically in response to your FY24 Adult Diversion and Correctional Treatment Fund application. Focused on addressing unmet behavioral health needs of those involved in the criminal legal system, SB 22-196 provides a total \$4,000,000 to strengthen and expand Colorado's §18-1.3-101, C.R.S., pretrial adult diversion programs in FY23 and FY24. This funding represents a huge step towards serving victims of crime and empowering those charged with its commission to disentangle themselves from the criminal legal system through rehabilitation and access to assistance needed for better individual, family, and community outcomes. As you have recognized in your application, diversion also increases efficiencies by freeing up prosecutorial, defense, and judicial resources for cases that most need them and reduces the pipeline of individuals who may require competency evaluation and restoration.

Funds unspent in FY23 are available in FY24 for allocation by the Funding Committee without further legislative appropriation. To foster program sustainability, the Funding Committee will allocate half of the \$4,000,000 appropriation in FY23 and half in FY24, less amounts required for administration of these federal funds. As shown on the attached table and pursuant to §13-3-115, C.R.S., the Funding Committee awards your program FY24 adult diversion funding of \$494,100 and Correctional Treatment funding of \$45,000. Awards are subject to reallocation after the third quarter of FY24. Any discouraged or prohibited items in your funding request have been removed.

In past years, the state general fund provided adult diversion funding. This year, the federal American Rescue Plan Act (ARPA) provides diversion funding through the Colorado Behavioral Health Cash Fund, pursuant to SB22-196. The federal character of the monies, along with language in SB22-196, may change administration of these funds at the state and program level, including but not limited to requiring:

- Compliance with federal funding authorities;
- Use of Sam.gov to ensure that non-DA service providers, including but not limited to treatment, restorative justice, or other providers of goods or services to diversion participants, are not precluded from receiving federal dollars;
- Prohibition against certain expenditures (e.g., restitution, training people who are not DA employees, participant incentives/stipends, food/coffee at meetings, anything that could be construed as entertainment or recreation, etc.);

- Use of timesheets, similar to the attached, for time and effort reporting to support staffing compensation for operating the adult diversion program;
- Completion of the attached risk assessment questionnaire;
- · Shorter, inflexible quarterly reporting deadlines; and
- Contract terms reflecting federal requirements.

To move forward with grant acceptance, please:

- Review §18-1.3-101, C.R.S., regarding adult diversion program requirements and prohibitions;
- Review attached SB22-10 and SB22-196, §§4 and 5, for statutory amendments to the adult diversion and funding committee statutes, which emphasize diversion of those with behavioral health disorders, although not to the exclusion of other diversion participants;
- Review, and complete the award acceptance and risk assessment on the attached form within 7 days of receipt;
- Using SAM.gov, confirm the eligibility to receive federal funds of entities with which the DA's office
 will subcontract or from whom the office may purchase goods or services, and continue using SAM.gov
 prior to transactions with additional entities;
- Attend the live or recorded program orientation (time and date TBD). DA staff and subcontractors who
 will be involved in day-to-day diversion program operations, reporting, grant accounting, or compliance
 are encouraged to attend; and
- Review, complete, and return the interagency agreement prepared by the State Court Administrator's Office as soon as possible after receiving and reviewing it.
