FIFTH AMENDATORY AGREEMENT

THIS FIFTH AMENDATORY AGREEMENT is made between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado (the "City"), and SAMSARA INC., a Delaware corporation, whose address is 1 De Haro Street, San Francisco, CA 94107 (the "Contractor"), individually a "Party" and collectively the "Parties."

WHEREAS, the Parties entered into an Agreement dated August 12, 2020, an Amendatory Agreement dated June 10, 2021, a Second Amendatory Agreement dated May 25, 2022, a Third Amendatory Agreement dated May 10, 2023, and a Fourth Amendatory Agreement dated October 23, 2024, to provide maintenance, tracking, and monitoring of City owned vehicles (the "Agreement"); and

WHEREAS, the Parties now wish to modify the Agreement as set forth below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties incorporate the recitals set forth above and amend the Agreement as follows:

1. Effective September 1, 2025, all references to Exhibits A, A-1, A-2, A-3, and A-4 in the existing Agreement shall be amended to read Exhibits A, A-1, A-2, A-3, A-4, and A-5, as applicable. Exhibit A-5 is attached and will control from September 1, 2025.

2. Section 17 of the Agreement, titled "<u>TERM</u>" is amended to read as follows:

"17. <u>TERM</u>: The term of the Agreement ("Term") shall commence on September 1, 2020, and expire, unless sooner terminated, on August 31, 2030. At the end of the Term, the Agreement may be renewed for an additional five (5) year term at an annual unit price not to exceed five percent (5%) of the previous annual unit price. At the end of the initial Term, the Parties may mutually agree to adjust the pricing based upon the City's actual or anticipated usage."

3. Subsection 18.4.1 of the Agreement, titled "<u>Maximum Contract Liability</u>," is amended to read as follows:

"**18.4.1.** Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed Ten Million Eight Hundred Ninety-Six Thousand Two Hundred Eighty-One Dollars and Eighty-Nine Cents (\$10,896,281.89) (the "Maximum Contract Amount"). The City is not obligated to execute an agreement or any amendments for any further services, including any services performed by the Contractor beyond that specifically described in the Exhibits. Any services performed beyond those in the Exhibits or performed outside the Term are performed at the Contractor's risk and without authorization under the Agreement."

4. Effective upon execution, a new Section 56, titled "<u>TITLE AND RISK OF LOSS</u>," is hereby added to the Agreement and shall read as follows:

"56. <u>**TITLE AND RISK OF LOSS**</u>: Title to the Samsara Hardware and Software purchased will vest to the City upon shipment. Risk of loss will remain with the Contractor until the Samsara Hardware is delivered to the City, and the City will replace lost or damaged Hardware in accordance with its Hardware Warranty and RMA Policy at no additional cost to the City."

5. Except as amended here, the Agreement is affirmed and ratified in each and every particular.

6. This Fifth Amendatory Agreement is not effective or binding on the City until it has been fully executed by all required signatories of the City and County of Denver, and if required by Charter, approved by the City Council.

7. The following attached exhibits are hereby incorporated into and made a material part of this Agreement: **Exhibit A-5**, Scope of Work.

Scope Statement Overview

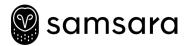

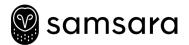

License Term

If Hardware associated with a then-unactivated Samsara Software license will be shipped to you under this Order Form, such Samsara Software license will be activated on the day the Samsara Hardware ships. Notwithstanding the foregoing, if you are renewing the license term for a previously- activated Samsara Software license under this Order Form, the License Start Date for the renewal license term shall be the day that Samsara extends your access to the Hosted Software for the renewal license term. Samsara Hardware requires a valid license to function.

If all such Hardware is shipped in one shipment, the license term for all such Hardware will be the full license term under this Order Form. If such Hardware is shipped in multiple shipments, only the license term of such Hardware in the initial shipment will be such full license term. The license term of the remaining such Hardware shipped after the initial shipment will be set to match the then-remaining license term of the initial shipment, so that the license term for all such Hardware under this Order Form expires on the same date.
