**A RESOLUTION**

**Approving and providing for the execution of a proposed Grant Agreement between the City and County of Denver and the Colorado Department of Public Health and Environment for the “Colorado Natural Resources Trustees Rocky Mountain Arsenal Recovery” program and the funding therefor.**

**WHEREAS**, the City and County of Denver has given due consideration to said proposed Grant Agreement;

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** The proposed Grant Agreement between the City and County of Denver and the Colorado Department of Public Health and Environment (CDPHE), for the “Colorado Natural Resources Trustees Rocky Mountain Arsenal Recovery” program, for implementation of the Montbello Landscape Transformation project, which is identified as Grant Contract Number 204247, a copy of which is duly filed with the City Clerk, Filing No 202580159, be and hereby is approved in all respects.

**Section 2.** The payments made by the CDPHE to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to the Grant and Other Money Project Funds Series (Accounting No. 38000), which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

**Section 3.** That it be and is hereby found and determined that the budget summary of said program, to be expended by the Executive Director of Parks and Recreation, is as follows:

Expenditure of said funds are authorized from the execution date of said grant agreement through December 31, 2029.
