**A BILL**

**For an ordinance authorizing expenditures in the Human Services Special Revenue Fund based on a letter of intent from United States of America to award funding for the "Emergency Solutions Grant FY12" program.**

**WHEREAS**, the United States Department of Housing and Urban Development (HUD) awards Emergency Solutions Grant (ESG) funds to the City and County of Denver annually; and

**WHEREAS**, HUD has sent a letter stating their intent to provide ESG FY12 funds to the Denver Department of Human Services; and

**WHEREAS**, the City and County of Denver has given due consideration to said letter of intent to fund, a copy of which is duly filed with the City Clerk, Filing No. 11-1065;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** Expenditures are hereby authorized from the Human Services Special Revenue Fund, Accounting No. 13000, the amounts of money in the following tabulation to be expended for the purposes and upon the authorizations in said Ordinance set forth:
