This ordinance will authorize Public Works to enter into a contract with TRANSWEST FREIGHTLINER, LLC. to obtain three(3) Freightliner Coronado SD Tractor Trucks and twenty (20) Freightliner 114 SD Cab and Chassis. The total cost of the three(3) Freightliner Coronado SD Tractor trucks and twenty (20) Freightliner 114 SD Cab and Chassis is \$2,836,996.00. Executive Summary

An ordinance to authorize Public Works to obtain three (3) Freightliner Coronado SD Tractor Trucks and twenty (20) Freightliner 114 SD Cab and Chassis financed through a companion capital lease purchase agreement with Chase Equipment Finance, Inc.

The City and County of Denver is seeking to purchase three (3) Freightliner Coronado SD Tractor Trucks and twenty (20) Freightliner 114 SD Cab and Chassis from TRANSWEST FREIGHTLINER, LLC. The proposed agreement is a zero dollar agreement that will allow the City to obtain the equipment and a companion agreement with Chase Equipment Finance, Inc., who is the financier. The cost of the equipment is \$2,836,996.00.

This purchase is part of a “catch-up” effort to address an aging fleet to reduce the cost of maintaining the aged fleet.

Because the City’s Charter requires Council approval of any agreement in excess of \$500,000 and this agreement is a companion to the financing agreement, this ordinance is requested.
