4 **A RESOLUTION**

5 **To set a public hearing relating to the adoption of the 1840 Grant Street Urban**
6 **Redevelopment Plan and directing the Denver Urban Renewal Authority to take**
7 **certain actions in connection with the hearing.**

9 **WHEREAS**, the Denver City Council desires to set a public hearing on the adoption of the
10 1840 Grant Street Urban Redevelopment Plan pursuant to C.R.S. § 31-25-107(3); and

11 **WHEREAS**, Denver City Council desires to delegate the responsibility for notice to the
12 Denver Urban Renewal Authority (the "Authority").

13 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY**
14 **OF DENVER:**

15 **Section 1.** Date, Time and Location of the 1840 Grant Street Urban Redevelopment Plan
16 Public Hearing. The City Council shall conduct a public hearing on the 1840 Grant Street Urban
17 Redevelopment Plan. The public hearing shall be on Tuesday, October 20, 2020, at 5:30 p.m. in
18 Council Chambers in the City and County Building located at 1437 Bannock Street, in Denver,
19 Colorado.

20 **Section 2.** Other Actions and Notices. The Authority is delegated the authority and directed
21 to give all written notices and publications required by C.R.S. § 31-25-107, including those required
22 under C.R.S. § 31-25-107(9.5).

23 **Section 3** Plan Submittal. That the 1840 Grant Street Urban Redevelopment Plan be
24 submitted to the City Council and Board of Equalization of the City, sitting as the Board of County
25 Commissioners in accordance with the Charter of the City.

26 **Section 4.** That the Clerk of the City and County of Denver shall attest and affix the seal of
27 the City and County of Denver to this Resolution.
