8 For an ordinance authorizing expenditures in the Human Services Special Revenue
9 Fund based on a letter of intent from United States of America to award funding for
10 the "Emergency Solutions Grant FY11" program.

12 WHEREAS, the United States Department of Housing and Urban Development (HUD) awards
13 Emergency Solutions Grant (ESG) funds to the City and County of Denver annually; and

14 WHEREAS, HUD has sent an award letter stating their intent to provide ESG FY11 funds to
15 the Denver Department of Human Services; and

16 WHEREAS, the City and County of Denver has given due consideration to said award letter, a
17 copy of which is duly filed with the City Clerk, Filing No. 11-308;

18 NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF
19 DENVER:

20 Section 1. Expenditures are hereby authorized from the Human Services Special Revenue
21 Fund, Accounting No. 13000, the amounts of money in the following tabulation to be expended for
22 the purposes and upon the authorizations in said Ordinance set forth:
