5 **A BILL**

6 **For an ordinance making a rescission from and an appropriation in the Culture**  
7 **and Recreation Special Revenue Fund, and authorizing a cash transfer to and**  
8 **an appropriation in the Parks, Trails and Open Space Capital Improvement**  
9 **Fund.**

10  
11 **WHEREAS**, the Parks, Trails, and Open Space Special Revenue Fund was created through  
12 Ordinance No. 0083, Series of 2019, to administer new revenue for improvement and expansion of  
13 Denver’s parks and recreation system, approved by Denver voters in 2018 through Ballot Measure  
14 2A, which increased sales and use taxes by 0.25 percentage points; and

15 **WHEREAS**, Ordinance No. 0686, Series of 2019, amended the Denver Revised Municipal  
16 Code to create the Parks, Trails and Open Space Capital Improvement Fund, Fund Series 36000,  
17 to receive transfers from the Parks, Trails, and Open Space Special Revenue Fund and support  
18 capital projects resulting from Ballot Measure 2A; and

19 **WHEREAS**, Ordinance No. 0687, Series of 2019, established the Parks Improvement  
20 Projects Fund, Fund Number 36050, in the Parks, Trails and Open Space Capital Improvement  
21 Fund to administer parks capital improvement projects; and

22 **WHEREAS**, the 2020 Annual Appropriation Ordinance appropriated budget for land  
23 acquisition in the Parks, Trails, and Open Space Special Revenue Fund to be transferred to the  
24 Parks, Trails, and Open Space Capital Improvement Fund at such time when property selections  
25 and costs were identified; and

26 **WHEREAS**, the Department of Parks and Recreation has now identified and wishes to  
27 purchase property at 4849 W. Kentucky Avenue, a parcel adjacent to Westwood Park, which is  
28 consistent with the Parks, Trails and Open Space Program Plan approved by City Council through  
29 Ordinance No. 0538, Series of 2019;

31 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF**  
32 **DENVER:**

1       **Section 1.** From appropriations heretofore made from the Culture and Recreation Special  
 2 Revenue Fund there is hereby RESCINDED the amount listed or indicated in the following tabulation  
 3 under the heading "Amount Rescinded" and transferred to the Culture and Recreation Special  
 4 Revenue Fund:

 6 out of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts  
 7 heretofore appropriated by Ordinance No. 1193, Series of 2019, and any supplemental  
 8 appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter  
 9 designated the amount of money following such designation, to be expended for the purposes and  
 10 upon the authorizations in said Ordinance set forth:

 16 No. 36000, out of monies transferred from Section 2 and not otherwise appropriated, and in addition  
 17 to amounts heretofore appropriated by Ordinance No. 1193, Series of 2019, and any supplemental  
 18 appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter  
 19 designated the amount of money following such designation, to be expended for the purposes and  
 20 upon the authorizations in said Ordinance set forth:
