A RESOLUTION

Approving and providing for the execution of proposed contracts between the City and County of Denver and the State of Colorado Division of Youth Corrections concerning the "Denver Youth" programs and the funding therefor.

WHEREAS, the State of Colorado, Division of Youth Corrections, has notified the City of funding allocations to assist at risk youth for the Statewide Senate Bill 94 Program;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:

Section 1. The proposed Grant Agreement between the State of Colorado and the City and County of Denver, which is identified as Grant Number 18IKAA100705, a copy of which is duly filed with the City Clerk, Filing No. 17-0152, be and hereby is approved in all respects.

Section 2. The payments made by the State of Colorado to the City pursuant to and under the Grant Agreement shall be deposited into the Treasury of the City and credited to Special Fund No. 12000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver.

Section 3. That it be and is hereby found and determined that the budget summary of said program is as follows:
