Crime Prevention and Control Commission has contracted with the State Judicial Department to support probation officers to manage misdemeanor cases in Drug Court. The proposed contract provides for a cumulative total that exceeds the threshold contained in Section 3.2.6(E) of the Charter requiring City Council approval. The proposed amendment adds \$124,338 resulting in the current cumulative cost of \$1,772,597.67 since 2006. Contract ends December 2012.
