9	the public hearing, that the map amendment set forth below conforms with applicable City laws, i			
10	consistent with the City's adopted plans, furthers the public health, safety and general welfare of the			
11	City, will result in regulations and restrictions that are uniform within the OS-A district, is justified by			
12	one of the circumstances set forth in Section 12.4.10.8 of the Denver Zoning Code, and is consistent			
13	with the neighborhood context and the stated purpose and intent of the proposed zone district;			
14	NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF			
15	DENVER:			
16	Section 1. That upon consideration of a change in the zoning classification of the land area			
17	hereinafter described, Council finds:			
18	a. The land area hereinafter described is presently classified as E-MX-3; E-MX-3, UO-1			
19	UO-2; E-TU-C; and E-SU-D.			
20	b. It is proposed that the land area hereinafter described be changed to OS-A.			
21	Section 2. That the zoning classification of the land area in the City and County of Denve			
22	described as follows shall be and hereby is changed from E-MX-3; E-MX-3, UO-1, UO-2; and E-TU
