This bill request rescinds a total of \$1,500,000 from the Denver Health Payment for Public Health Clinic and \$300,000 from Denver CARES, as follows:

The foregoing transfer supports a fiscal year 2023 amendment to the Denver Health and Hospital Authority (DHHA) Operating Agreement (OA) for Medically Indigent Payment funding gaps. This amendment is in response to a request from City Council. This one-time amendment to the 2023 DHHA OA allows savings/underspend from the 2023 Public Health Clinics Payment and the 2023 Denver CARES Payment to be used towards the Medically Indigent Payment. This ordinance is a companion to the ordinance amending the Fiscal Year 2023 Denver Health and Hospital Authority Agreement.
