 - a. Scope of Work
 - 1. Shared Services As the final step to complete the Human Resources Shared Services consolidation, Career Service requires budget authority to fund its newly formed centralized staff for the remainder of 2010. The total expenditures needed to cover the reminder of 2010 is \$1,791,000. This amount will be a neutral impact for the General Fund. \$805,000 will be covered through a rescission/re-appropriation moving expending authority from General Fund agencies to CSA. The balance, \$986,000, will be reimbursed as revenue from non-General Fund agencies.

Employers will be able to recover their portion of the premium through a credit from the Internal Revenue Service, which will be funded by CSA on behalf of all city agencies. A supplemental of \$280,000 is needed to fund this federal mandate, and this amount will be offset by a federal reimbursement
