[17-1426](#) Approves an Intergovernmental Agreement with Greenwood Village and Arapahoe County for \$250,000 from each party for a total of \$750,000, and for three years for studying and designing certain roadway improvements at the Interstate 25 and Belleview interchange in Council District 4 (201738540).
