6. **General description/background of proposed ordinance including contract scope of work if applicable:** The SHE 2014/FASTER 2015 is a federal/state funded traffic signal upgrade project. The goal of this project is to reconstruct and upgrade five (5) existing traffic signals within the City and County of Denver. Three signals are located on Colorado Blvd at Mississippi, Louisiana, and Arkansas, and the remaining two signals are located at Havana/Girard and Sheridan/20th. The scope of work is to rebuild the traffic signals by removing the existing traffic signal equipment (poles, signal and pedestrian indications, and associated equipment) and replacing it with new traffic signal equipment in accordance with the City and County of Denver standards.
