## 5. General description or background of proposed request. Attach executive summary if more space needed:

Denver Connection West Metropolitan District and Denver Parks and Recreation have partnered together to build and acquire a new park in the Avion Community (at Kittredge Street and E. Bolling Dr.). Located between the Montbello and Green Valley Ranch neighborhoods, this new parcel will provide approximately 9 acres of new parkland and open space.

Neighborhood Meetings concluded in December 2022. The community prioritized a community-sized playground, basketball court, two athletic fields, and a walking loop around the park. The park will also provide native landscaping, new trees, picnic areas, bench seating, and an urban food forest.

The cost of construction of the park is ~\$8.75 million, with CCD providing \$4 million and vendors providing the balance of \$4.75 million. The park will be conveyed to the city.
