A portion of land conveyed by Warranty Deed to the City & County of Denver, recorded on the 10th of October 2006 by Reception Number 2006161883 in the City and County of Denver Clerk & Recorders Office being more particularly described as follows:

All that portion of said deed except that portion being 4.00 feet south of and parallel with the southerly right of way of West Columbia Place said parcel of land also being a portion of Block 42, Bear Valley Subdivision as recorded in Plat Book 24 at Pages 16-20 in the office of Clerk and Recorder of the City and County of Denver, said parcel being located in the southeast quarter of Section 36, Township 4 South, Range 69 West of the Sixth Principal Meridian, City and County of Denver, State of Colorado, more particular described as follows:

Commencing at the northwest corner of Lot 1, Block 30, Bear Valley Subdivision; Thence S 69°08'00" E along the south right of way line of West Columbia Place a distance of 758.16 feet to the Point of Beginning; Thence continuing along the south right of way of said West Columbia Place the following three (3) courses;

- 1) Thence S 69°08'00" E a distance of 21.84 feet;**
- 2) Thence along a curve to the left with the radius of 1050.00 feet, a central angle of 21°00'00", an arc length of 384.85, and a chord bearing S 79°38'00"E a distance of 382.69 feet;**
- 3) Thence N 89°52'00" E a distance of 18.97 feet to the Northwest corner of the land described at Book 2143, Page 613 filed in the City and County of Denver Clerk and Recorders Office on April 21, 1980;**

Thence along the Westerly Boundary of the land described at said Book 2143, Page 613 the following three (3) courses;

- 1) Thence S 45°08'00" E a distance of 16.97 feet;**
- 2) Thence S 00°08'00" E a distance of 178.00 feet;**
- 3) Thence along a curve to the right with a radius of 20.00 feet, A central angle of 90°00'00", an arc length of 31.42, a chord bearing of S 44°52'00" W a distance of 28.28 feet;**

Thence N 00°08'00" W a distance of 4.00 feet; Thence running parallel with and 4.00 westerly of the westerly boundary of the land described at said Book 2143 Page 613 the following three (3) courses;

- 1) Along a non-tangent curve to the left with a radius of 16.00 feet, a central angle of 90°00'00", an arc length of 25.13 feet, and a chord bearing of N 44°52'00" E a distance of 22.63 feet;**
- 2) Thence N 00°08'00" W a distance of 176.34 feet;**
- 3) Thence N 45°08'00" W a distance of 13.66 feet;**

Thence running parallel with and 4.00 feet southerly of the southerly right of way line of West Columbia Place the following three (3) courses;

- 1) Thence S 89°52'00" W a distance of 17.31 feet;
- 2) Thence along a curve to the right with a radius of 1054.00 feet, an arc length of 386.31 feet, a central angle of 21°00'00", and a chord bearing of N 79°38'00" W a distance of 384.15 feet;
- 3) Thence N 69°08'00" W a distance 20.32 feet;

Thence N 00°02'29" W a distance of 4.29 feet to the Point of Beginning.

Said parcel contains 2582 square feet, 0.06 Acres, more or less.
