- BR13- Approves a \$1,849,131 purchase order with Pierce Manufacturing for 4
0111 Pierce Velocity Pumpers for the Fire Department under the Planned
Fleet Replacement Program. (PWOPS0000008167).
- RR13- Approves the Mayoral appointment of Robert "Bob" Nogueira, Jr. to the
0103 Career Service Board for a term effective immediately and expiring
September 15, 2015.

- BR13- Amends the Denver Rescue Mission contract to add \$175,200 for a

management for 300 adults who are discharged from hospital settings
CE04013 (3)).

contract amount of \$573,828 for the Family Seniors and Homeless
Initiative program which provides mentoring services and financial
