**A BILL**

**For an ordinance establishing a new Fund in the Community Development Special Revenue Fund Series for the “Homelessness Resolution” Program and appropriating budget for the fund in 2021.**

**WHEREAS**, in the Denver General Election in November 2020, Denver voters approved Referred Measure 2B to increase the Denver sales tax rate by 0.25 percentage points to expand support for housing, shelter, and other services for those experiencing or exiting homelessness without supplanting General Fund appropriations allocated each year to the Department of Housing Stability; and

**WHEREAS**, the City and County of Denver passed Ordinance No. 782 in Series 2020 to compile and codify the fund plan, tax imposition, and tax remittance portions of the four sales and use tax increases approved by the people of the City and County of Denver; and

**WHEREAS**, the City and County of Denver wishes to create a special revenue fund to receive this additional sales tax revenue and administer the new program;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** A new fund is hereby established in the Community Development Special Revenue Fund Series, Accounting No. 16000, a “Homelessness Resolution” Fund, Accounting No. 16813, for the purpose of receiving and accounting for the Homelessness Resolution Program’s portion of sales and use tax receipts.

**Section 2.** Monies received from Denver sales and use tax collections which are determined to be the Homelessness Resolution Program’s portion of such collections, as well as any interest earned on said monies, shall be deposited into the Treasury of the City and credited to Special Revenue Fund No. 16000, which is set forth and described in Section 20-18 of the Revised Municipal Code of the City and County of Denver, and specifically to Accounting No. 16813-0145000.

1       **Section 3.** Program expenditures are hereby authorized for the “Homelessness Resolution”  
2 Program Fund, Accounting No. 16813, to be expended by the Executive Director of the Department  
3 of Housing Stability. Authorized expenditures and administrative spending caps for Accounting No.  
4 16813 include those stipulated in article VII of Chapter 27 of the Denver Revised Municipal Code,  
5 as amended by Referred Measure 2B and any subsequent amendments. This is an appropriated,  
6 non-lapsing fund.

7       **Section 4.** For the year 2021, there is hereby appropriated to the appropriation account  
8 hereinafter designated in the amount of money following such designation, to be expended for the  
9 purposes and upon the authorizations in said Ordinance set forth:

11 Starting in 2022, expenditures for the “Homelessness Resolution” Program Fund shall be  
12 authorized by the annual appropriation ordinance.

13       **Section 5.** To ensure that the correct amount of revenue is dedicated to this voter-approved  
14 program, the amount appropriated each year shall be increased or decreased by the difference  
15 between (1) the prior year’s appropriation that was based upon estimated revenues and (2) the  
16 actual revenues received in the prior year as determined by the annual audit of the City’s financial  
17 statements, per fiscal year-end close.

18       **Section 6.** The Chief Financial Officer of the City and County of Denver is hereby authorized  
19 and directed to make such book and record entries and to do such other things as may be  
20 necessary to accomplish the purposes of this Ordinance.
