The agreement includes reopening 2013-2015 CBA to increase 2015 salary by 1.5% on July 1, 2015; 2% increase on January 1, 2016; 2% increase on July 1, 2016; 2% increase on January 1, 2017; 2% increase on July 1, 2017; and a 3% increase on January 1, 2018.
