Sixth Amendment to Intergovernmental Agreement (IGA) for the Denver Fire Department to provide fire protection services within the municipal boundary of the City of Sheridan (including specific fire prevention services—plan reviews, fire safety inspections, etc.). In 2010, the City and County of Denver entered into an agreement with the City of Sheridan to provide fire suppression services for its citizens. The initial IGA was approximately a 2-year period (9/15/10-12/31/12). Beginning with the Second Amended and Restated Agreement, City of Sheridan officials requested for the review and renewal of the IGA on an annual basis.
