## FIRST AMENDMENT TO AGREEMENT

**THIS FIRST AMENDMENT TO AGREEMENT**, made and entered into as of the date set forth on the signature page, below, by and between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado ("City"), Party of the First Part, and **INSIGHT GLOBAL, INC.**, a corporation organized under the laws of Delaware and authorized to do business in the state of Colorado ("Consultant"), Party of the Second Part;

### WITNESSETH:

**WHEREAS**, the parties hereto entered into an Agreement dated October 5, 2011, (the "Existing Agreement") for on-call technology maintenance and support services at Denver International Airport (the "Airport"); and

**WHEREAS**, the parties now desire to amend the Existing Agreement to increase the Maximum Contract Liability thereof;

**NOW, THEREFORE**, for and in consideration of the premises and other good and valuable consideration, the parties hereto agree as follows:

1. Subparagraph 4.D.i., "Compensation and Payment; Maximum Contract Liability" of the Existing Agreement is hereby amended by deleting the said subparagraph in its entirety and substituting in its place the following:

**"4. COMPENSATION AND PAYMENT:**

**D. Maximum Contract Liability:**

(i) Any other provision of this Agreement notwithstanding, in no event shall the City be liable to pay for services rendered and expenses incurred by the Consultant under the terms of this Agreement for any amount in excess of One Million Five Hundred Thousand Dollars and No Cents (\$1,500,000.00) (the "Maximum Contract Liability"). Funding under the provisions of this paragraph 4.D. may be payable from the City's Airport System Capital Replacement Fund and/or Airport Operations and Maintenance Fund. The Consultant acknowledges that the City is not obligated to execute an Order, agreement or an amendment to this Agreement for any services and that any services performed by Consultant beyond that specifically described in an Order are performed at Consultant's risk and without authorization under this Agreement.

2. Except as modified or amended by this First Amendment to Agreement, all of the terms, provisions and conditions of the Existing Agreement are and shall remain valid,

enforceable and in full force and effect as though fully set forth herein.

3. This First Amendment to Agreement shall not be or become effective or binding on the City until it is approved by City Council for the City and County of Denver, if required by law, and fully executed by all signatories of the City and County of Denver.
