

## AMENDATORY AGREEMENT

**THIS AMENDATORY AGREEMENT** is made between the **CITY AND COUNTY OF DENVER**, a municipal corporation of the State of Colorado (the “City”) and **i3 INTEGRATION LLC**, a Colorado limited liability company, whose address is 6023 S. Andes Court, Aurora, Colorado 80016(the “Consultant”), jointly “the Parties”.

The Parties agree as follows:

### RECITALS:

1. The City and the Consultant previously entered into an Agreement dated May 24, 2013 for professional services for Program Financial Assurance related to Denver International Airport South Terminal Redevelopment Program (the “Agreement”); and

2. The City and the Consultant wish to amend the Agreement to include Phase 2 services as described in the Agreement and to increase the total compensation.

**NOW, THEREFORE**, in consideration of the premises and the mutual covenants and obligations herein set forth, the parties agree as follows:

1. All references to “...**Exhibit B**” in the existing Agreement shall be amended to read: “...**Exhibit B** and **B-1**, as applicable...” The Billing Rates for 2014-2015 marked as **Exhibit B-1** is attached and incorporated herein.

2. Section 2(a), **Services to be Performed**, of the Agreement is hereby amended to read in its entirety as follows:

“a. As the Manager directs, the Consultant shall diligently undertake, perform, and complete all of the services and produce all the deliverables set forth as Phase 1 and Phase 2 on **Exhibit A** to the City’s satisfaction.”

3. Section 3(a), **Compensation and Payment**, of the Agreement is hereby amended to read in its entirety and as follows:

“a. **Fee**: The City shall pay and the Consultant shall accept as the sole compensation for services rendered and costs incurred under the Agreement an amount not to exceed **\$1,075,000** for Phase 1 and Phase 2 services. Amounts billed may not exceed the rates set forth in **Exhibit B** for services provided prior to the date of this Amendatory Agreement and **Exhibit B-1** for services provided on or after the date of this Amendatory Agreement.

4. Section 3(d) of the Agreement is hereby amended to read in its entirety as follows:

“d. **Maximum Contract Amount**:

(1) Notwithstanding any other provision of the Agreement, the City's maximum payment obligation will not exceed **ONE MILLION SEVENTY FIVE THOUSAND AND NO/100 DOLLARS (\$1,075,000.00)** (the "Maximum Contract Amount"). The City is not obligated to execute an Agreement or any amendments for any further services, including any services performed by Consultant beyond that specifically described in **Exhibit A**. Any services performed beyond those in **Exhibit A** are performed at Consultant's risk and without authorization under the Agreement.

5. Except as amended herein, the Agreement is affirmed and ratified in each and every particular.
