9 **Approving the City Council appointments of Mariana Diniz Esteves, Rick Acosta,
10 and Jasmine Crane to the Denver County Cultural Council**

12 WHEREAS, Colorado Revised Statute 32-13-103(3) provides for the appointment of a county
13 cultural council by the Denver City Council to provide for the distribution of Tier III revenues as
14 required by the Denver Metropolitan Scientific and Cultural Facilities District; and

16 WHEREAS, the eleven-member Denver County Cultural Council has been established by the City
17 Council to institute procedures for the application and determination of the distribution of Tier III
18 funding; and

20 WHEREAS, the ordinance establishing the Denver County Cultural Council requires the
21 appointment of eight members by the City Council for staggered terms of two, three, and four years
22 and three members representing Denver Arts & Venues, Visit Denver, and Denver Public Schools,
23 each for two-year terms.

25 NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY AND COUNTY OF
26 DENVER:

28 SECTION 1. That the Council hereby appoints Mariana Diniz Esteves, Rick Acosta, and Jasmine
29 Crane to the Denver County Cultural Council for a term effective immediately and ending October
30 1, 2018, or until successors are duly appointed.

32 SECTION 2. That the Clerk of the City and County of Denver shall attest and affix the seal of the
33 City and County of Denver to this resolution and that copies hereof be transmitted to the Denver
34 County Cultural Council.
