THIRD AMENDMENT TO AIRPORT USE AND FACILITIES LEASE AGREEMENT

THIS THIRD AMENDMENT TO AGREEMENT is made and entered into as of this day of ______, 2011, by and between the City and County of Denver, a municipal corporation of the State of Colorado ("the City"), and US AIRWAYS, INC., a Delaware corporation ("Airline,") Party of the Second Part.

WITNESSETH

WHEREAS, the parties hereto entered into a certain Airport Use and Facilities Lease Agreement dated May 17, 2005, as amended by a First Amendment dated October 16, 2007 and a Second Amendment dated October 12, 2010 (the "Existing Agreement"), under which the City ("Airport"); and

WHEREAS, the parties hereto desire to amend the Existing Agreement as hereinafter provided;

NOW, THEREFORE, the Existing Agreement is modified as set forth herein.

- 1. Exhibit D-3, Terminal Space is now effective January 1, 2011
- 2. Paragraph 6.01, "TERM OF AGREEMENT," of the Existing Agreement is deleted in its entirety and replaced with the following:

"The term of this Agreement shall commence on March 1, 2005 and shall terminate at Noon MST on December 31, 2011, unless this Agreement is earlier cancelled, terminated, or extended as hereinafter provided."

- 3. Except as otherwise modified or amended herein, all terms and conditions of the Existing Agreement shall remain in full force and effect as though set out in full herein.
- 4. This Third Amendment to Airport Use and Facilities Lease Agreement is expressly subject to and shall not be or become effective or binding on the City until approved by the Denver City Council and fully executed by all signatories of the City.


