## Committee Consent Agenda

### **Business, Workforce & Sustainability**

BR14-0538 Approves a three-year ground transportation concession agreement with Colorado Mountain Express, Inc. for a minimum annual guaranty of \$108,000 to provide ground transportation at Denver International Airport (PLANE-201415109-00).

BR14-0539 Approves a three-year ground transportation concession agreement with SuperShuttle International Denver, Inc. for a minimum annual guaranty of \$120,600 to provide ground transportation at Denver International Airport (PLANE-201415110-00).

BR14-0543 Adds \$392,000 to the existing agreement with the USDA/APHIS-Wildlife Services (for a new total of \$1,532,643) and extends the term through 12-31-15 to implement the Federal Aviation Administration-approved Wildlife Hazard Management Plan at Denver International Airport (PLANE - 201103051 - 03).

BR14-0544 Adds \$40,000 to the Inter-Governmental Agreement with the Town of Morrison for additional wastewater treatment services at Red Rocks Amphitheater through 10-1-14 (CE45001(1)).

### **Government & Finance**

BR14-0542 Adds Lead Youth Counselor at 616-A pay grade to the City employee Classification and Pay Plan.

### **Land Use, Transportation & Infrastructure**

BR14-0536 Authorizes receipt of revenue, establishes a capital grant fund and appropriates \$23,360,000 from the Colorado Department of Transportation for improvements on Federal between 7th Avenue and Holden Place in Council District 9.

BR14- Approves an Inter-Governmental Agreement by which Denver Water will reimburse the City \$1,145,149.82 for the design and construction of water distribution lines and relocation of a steel conduit in Broadway from Arizona to Kentucky and in Mississippi from Logan to Acoma in Council District 7 (201416527).

BR14- Amends a contract with Tsiouvaras Simmons Holderness to add \$1,055,766, for a revised maximum contract amount of \$2,414,886, and extends the term through 10-31-16 to provide construction related engineering design services on Federal between 5th Avenue and Howard Place in Council District 9 (CE02011-02).

RR14- Dedicates a parcel of land as public alley right-of-way as part of a redevelopment project at the intersection of 21st and Decatur Street in Council District 1.

BR14- Amends the 5-year, \$921,101.33 contract with TransCore ITS for the installation of a new centralized traffic signal control system to add the "Colorado Department of Transportation" as a Third Party Beneficiary of the agreement (201314013).

Routine, non-controversial requests for ordinances that are not substantive policy changes may be placed on Consent Agendas for Council Committees each week with the approval of Committee chairs. Councilmembers receive the consent agendas for review and have until Thursday at noon to request that an item be scheduled for Committee discussion.
