11	WHEREAS, pursuant to the provisions of Section 12-61 of the Denver Revised Municipal				
12	Code ("DRMC"), and by Ordinance No. 302, Series of 2019, there has been approved a				
13	Comprehensive Plan for the City and County of Denver ("Comprehensive Plan 2040"); and				
14	WHEREAS, said Section 12-61 of the DRMC provides for the supplementation of				
15	Comprehensive Plan 2040; and				
16	WHEREAS, by Ordinance No. 318, Series of 2007, the City accepted the Downtown Area				
17	Plan as an amendment to the city's comprehensive plan; and				
18	WHEREAS, by Ordinance No. 20180561, Series of 2018, the City accepted the Downtown				
19	Area Plan Amendment: Central Platte Valley-Auraria District as part of the city's comprehensive				
20	plan by amending the Downtown Area Plan; and				
21	WHEREAS, except for the Downtown Area Plan Amendment: Central Platte Valley-Auraria				
22	District Plan, the City wishes to repeal and replace the Downtown Area Plan with an updated				
23	comprehensive plan supplement, entitled Downtown Denver Area Plan, for the orderly growth and				
24	harmonious development of the City and County of Denver; and				
25	WHEREAS, pursuant to the provisions of Section 12-61 DRMC, the City wishes to				
26	supplement Comprehensive Plan 2040 by approving and accepting the Downtown Denver Area				
27	Plan; and				
28	WHEREAS, members of the City Council, duly authorized by the president of council have				
29	monitored the process whereby said Downtown Denver Area Plan has been formulated; and				
30	WHEREAS, the Downtown Denver Area Plan has been approved by the Denver Planning				
31	Board; and				
32	WHEREAS, the Manager of Community Planning and Development has transmitted the				
33	Downtown Denver Area Plan to the Mayor and Council for acceptance as a supplement to				
34	Comprehensive Plan 2040; and				
35	NOW THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF				

DENVER;

Section 1. That the proposed Downtown Denver Area Plan, consisting of a document of the same name filed with the City Clerk, Ex-Officio Clerk of the City and County of Denver, on the 4th day of November as City Clerk Filing No. 20250178, is hereby adopted and accepted as a supplement to Comprehensive Plan 2040, pursuant to Section 12-61(d) of the DRMC.

Section 2. That except for the Downtown Area Plan Amendment: Central Platte Valley-Auraria District, the Downtown Denver Area Plan replaces and supersedes the Downtown Area Plan.

Section 3. That the Downtown Area Plan Amendment: Central Platte Valley-Auraria District shall be treated as an amendment to the Downtown Denver Area Plan.

Section 4. That this adoption and acceptance of the Downtown Denver Area Plan, and of any amendment thereto, in conjunction with Comprehensive Plan 2040, is intended to establish the official guide for officials of the City and County of Denver and private citizens when making decisions affecting the future of land use and transportation in and for the City and County of Denver, as defined in said plan; provided however, that such approval shall not preempt the decision making powers vested by law or administrative directive in the Mayor, the Council or any other official of the City and County of Denver with respect to, but not limited to: a zoning map amendment, a zoning language amendment, a dedication or vacation of a street, alley or other public way, a designation of a park, the issuance of a revocable permit, a conveyance or acquisition of real property by the City and County of Denver, or an appropriation for or construction of a capital improvement; and provided, further that it is expressly understood that judgment must be exercised in the application of Downtown Denver Area Plan in the decision making processes of the Mayor, Council and other officials of the City and County of Denver.
