**A BILL**

**For an ordinance making a rescission from General Fund Contingency and making appropriations to agency General Fund, Special Revenue Funds, Capital Funds, and Enterprise Funds.**

**WHEREAS**, the Department of Transportation and Infrastructure requests \$3,100,000 to cover inflation driven increases to fuel, parts for fleet repairs, and cost and complexity of outsourced repairs due to the age of the fleet infrastructure; and

**WHEREAS**, the Clerk and Recorder requests \$1,100,000 to purchase security film for the Elections building and for the inflationary cost of ballot printing; and

**WHEREAS**, the Climate Action Sustainability and Resiliency Office requests \$21,900 to address an error that was identified from 2019 for revenue that was recorded in the General Fund instead of the Green Buildings SRF;

**NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:**

**Section 1.** From appropriations heretofore made from the General Fund listed or indicated in the following tabulation there is hereby RESCINDED the amount listed or indicated in such tabulation under the heading "Amount Rescinded" and transferred to the General Fund:

**Section 2.** From the General Fund, Accounting No. 01010, out of monies rescinded from Section 1 not otherwise appropriated and in addition to amounts heretofore appropriated by Ordinance No. 1284, Series of 2021, and any supplemental appropriations or rescissions, there is hereby appropriated to the appropriation accounts hereinafter designated the amount of money following such designation, to be expended for the purposes and upon the authorizations in said Ordinance set forth:
