11	BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY OF DENVER:
12	Section 1. Upon consideration of the recommendation of the Manager of Public Works
13	that an ordinance be enacted for the purpose of assessing the annual costs of the continuing
14	care, operation, repair, maintenance and replacement of the Consolidated Morrison Road
15	Pedestrian Mall, for the upcoming year, upon the real property, exclusive of improvements
16	thereon benefited the Council finds, as follows:

17 (a) A local maintenance district providing for the continuing care, operation, repair,
18 maintenance and replacement of the Consolidated Morrison Road Pedestrian Mall, was created
19 by Ordinance No. 792, Series of 2004;

(b) The annual cost of the continuing care, operation, repair, maintenance and
 replacement of the Consolidated Morrison Road Pedestrian Mall is \$77,200, which amount the
 Manager of Public Works has the authority to expend for the purposes stated herein;

(c) The Manager of Public Works has complied with all provisions of law relating to the
 publishing of notice to the owners of real properties to be assessed and to all persons interested
 generally, and the Council sitting as a Board of Equalization has heard and determined all written
 complaints and objections, if any, filed with the Manager of Public Works;

(d) The Consolidated Morrison Road Pedestrian Mall currently has sufficient reserves
 to pay for \$18,810.00 of the 2015 annual costs of the continuing care, operation, repair,
 maintenance and replacement of the Consolidated Morrison Road Pedestrian Mall.

30 (e) The portion of the annual costs for the continuing care, operation, repair,
 31 maintenance and replacement of the Consolidated Morrison Road Pedestrian Mall to be
 32 assessed against the properties, exclusive of improvements thereon, benefited are \$58,214.86;

(f) The portion of the annual costs of the continuing care, operation, repair,
 maintenance and replacement of the Consolidated Morrison Road Pedestrian Mall to be borne
 by the City and County of Denver is \$175.14; and

1 (g) The real property within the Consolidated Morrison Road Pedestrian Mall will be 2 benefited in an amount equal to or in excess of the amount to be assessed against said property 3 because of the continuing care, operation, repair, maintenance and replacement of said 4 Pedestrian Mall.

Section 2. The annual costs of the continuing care, operation, repair, maintenance and
 replacement of the Consolidated Morrison Road Pedestrian Mall to be assessed against the real
 properties, exclusive of improvements thereon, benefited are hereby approved.

8 **Section 3.** The annual costs of the continuing care, operation, repair, maintenance and 9 replacement of the Consolidated Morrison Road Pedestrian Mall in the amount of \$58,214.86 are 10 hereby assessed against the real properties, exclusive of improvements thereon, within said 11 local maintenance district as follows:
