7 **For an ordinance authorizing a capital equipment purchase from the Risk**
8 **Management Fund (SRF 11838) Fund for Department of Transportation and**
9 **Infrastructure.**

11 **WHEREAS**, the Department Of Transportation and Infrastructure (DOTI) is seeking
12 approval for a capital equipment purchase of a vehicle to replace a vehicle totaled while in service;
13 and

14 **WHEREAS**, said vehicle is critical to DOTI’s daily private development construction
15 inspection needs; and

16 **WHEREAS**, the totaled vehicle will be replaced with a new Electric Vehicle; and

17 **WHEREAS**, said replacement vehicle has been approved by the Department of Finance
18 (DOF), Risk Management Division to be purchased out of Special Revenue (11838); and

19 **WHEREAS**, capital equipment items with costs above the fifty-thousand-dollar threshold
20 require City Council authorization;

22 **NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE CITY AND COUNTY**

25 **Section 1.** From the Risk Management Special Revenue Fund, Accounting No. 11838, the
26 Chief Financial Officer, or duly authorized representatives, is hereby authorized to purchase or
27 acquire the following capital equipment:

28 The foregoing vehicle purchase will support DOTI operations.

1 **Section 2.** The Chief Financial Officer of the City and County of Denver is hereby authorized
2 and directed to make such book and record entries and to do such other things as may be necessary
