AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT is made and entered into by and between the CITY AND COUNTY OF DENVER, a municipal corporation of the State of Colorado ("City") and DENVER CHILDREN'S ADVOCACY CENTER., a Colorado nonprofit corporation, with its principal place of business located at 2149 Federal Boulevard, Denver, Colorado 80211 ("Consultant"), who shall be individually referred to herein as a "Party" and jointly as the "Parties"

WITNESSETH:

WHEREAS, the Parties entered into an agreement dated December 19, 2013 to provide forensic interviews to children under the age of fifteen that are under the protection of the Denver Police Department ("Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to extend the term and increase the maximum contract amount.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and obligations herein set forth, the Parties agree as follows:

- **1.** Article 2 of the Agreement entitled "<u>**TERM**</u>" is hereby amended to read as follows:
 - **"2. TERM:** The term of the Agreement is from December 19, 2013 until December 31, 2015, or until the Maximum Contract Amount specified in sub-section 3.A. below is expended and all of the Tasks specified in **Exhibit A** have been satisfactorily performed, whichever is sooner, unless this Agreement is terminated earlier as provided in this Agreement or is extended as provided in a separate amendment to this Agreement ("**Term**"). Subject to the Manager's prior written authorization, the Consultant shall complete any work in progress as of the expiration date and the Term of the Agreement will extend until the work is completed or earlier terminated by the Manager. The Parties may, by written amendment, extend the Term of this Agreement for up to two (2) additional one (1) year periods utilizing the same pricing and other material terms and provisions of the Agreement."
- **2.** Article 3 subsection A entitled "<u>Maximum Contract Amount</u>" is amended to read as follows:
 - "A. Maximum Contract Amount: The Maximum Contract Amount to be paid by the City to the Consultant for the performance of the work set out in **Exhibit A** shall in no event exceed the sum of **SIX**

HUNDRED FORTY TWO THOUSAND DOLLARS AND NO CENTS (\$642,000.00), unless this Agreement is modified to increase said amount by a duly authorized and written amendment to this Agreement executed by the Parties in the same manner as this Agreement."

3. Except as herein amended, the Agreement is affirmed and ratified in each and every particular.
