6. General description of proposed ordinance including contract scope of work if applicable:

Requesting an amendment for the continuity of on-call construction services that provides inside and outside plant telecommunication infrastructure engineering, construction and installation services. This proposed amendment adds additional term and dollars to the fee and maximum contract liability articles due to the large volume of work anticipated to be applied to these contracts in the coming years. The work performed is task-order based. Each task-order is bid among the three on-call contractors to ensure the best pricing for DEN. The on-call construction work will consist of locating and/or relocating existing cable infrastructure and installation of new services to support new construction of buildings, standalone communications "huts," internal distribution frame (IDF) rooms, and other structural components that require telecommunications services.
